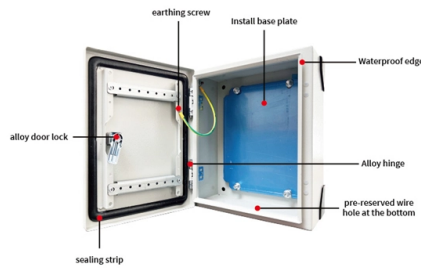


Technical Requirements for Pipeline Optical Cables
